### HIRE AGREEMENT

### **Terms and Conditions of Hire**

It is the responsibility of the person who is hiring this Bouncing Castle to ensure that all possible steps are taken to avoid injury or damage to the Inflatable.

If you follow these simple guidelines a happy and safe time will be had by your children and guests, thank you for your time in reading this:

- This unit is suitable for all ages from 8 years.
- All safety equipment must be used at all times and fitted appropriately.
- A responsible Adult must supervise the equipment at all times.
- No food, drinks or chewing gum to be allowed on or near the Equipment which will avoid choking and mess (Please note if the Inflatable is collected in a dirty condition then the person hiring it will incur a cleaning charge).
- All shoes, glasses, jewellery, badges MUST be removed before using the Equipment.
- No face paints, party poppers, coloured streamers or silly string to be used either on or near the Equipment.
- No smoking or barbecues near the Equipment.
- No climbing or jumping on the demolition ball supports, children may have a nasty fall or land on the fan blower causing injury. The hirer will be held responsible for the full cost incurred for any damage caused by misuse.
- DO NOT allow anybody to swing from the demolition ball.
- Always ensure that the Equipment is not overcrowded, and limit numbers according to the age and size of Children using it.

  Try to avoid large and small Children from using it at the same time.
- Ensure children are not pushing, colliding, fighting or behaving in a manner likely to injure or cause distress to others.
- If the Equipment is not being used for any part of the day, please switch the blower off at the mains.
- Ensure that no-one with a history of back or neck problems is allowed on the Equipment as indeed any child who is feeling unwell.
- Do not allow anyone to be on the Equipment during inflation or deflation as this is DANGEROUS.
- No pets, toys or sharp instruments to be allowed on or near the Equipment.
- Please ensure that Children are not attempting somersaults and are clothed appropriately and that nothing can fall out of their pockets.
- In the event of rain it is recommended that the unit should not be used.
- The Equipment should not be used if it becomes wet on the bed area.
- In the event of heavy rain, it is strongly recommended that the Equipment be switched on. Any wetness, including bubbling (which is normal) can be dried with a towel.
- In the event that the blower stops working, please ensure all users get off the inflatable immediately. If the blower has a safety reset button, try pressing this, also check the fuses and make sure the blower tube or deflation tube has not come undone or something has not blown onto it and is obstructing the blower. In the event that it overheats, or loses power, switch the blower off at the mains, then switch it back on again 1 or 2 minutes later, and it should restart. If it does not, inform us straight away.
- Please make periodic checks to ensure the equipment is still firmly anchored to the ground, especially in windy conditions. If the equipment works any anchor point loose, please vacate the equipment and secure the anchor stake. If you are worried that the equipment is insecure please deflate and call us immediately.
- In the event of high winds during your hire, it is strongly advised that the equipment is deflated and kept anchored to the ground until we arrive to take it away.
- Any damage caused by misuse or excessive un-cleanliness is chargeable.
- Do not allow anyone to access the equipment when it is in use.
