





















# Plymouth Bouncy Castles & Inflatable Games Hire

## Hire Agreement Terms and Conditions of Hire

**It is the responsibility of the person who is hiring this Inflatable equipment to ensure that all possible steps are taken to avoid injury or damage to the Inflatable. If you follow these simple guidelines a happy and safe time will be had by your children and guests, thank you for your time in reading this:**

-  This unit has an age limit of 11. Please ensure no-one over this age uses the equipment. **No adults** are to use this slide.
-  A responsible Adult must supervise the Inflatable Slide at all times.
-  No food, drinks or chewing gum to be allowed on or near the Inflatable Slide which will avoid choking and mess (Please note if the Inflatable is collected in a dirty condition then the person hiring it will incur a cleaning charge).
-  All shoes, glasses, jewellery, badges **MUST** be removed before using the Inflatable Slide.
-  No face paints, party poppers, coloured streamers or silly string to be used either on or near the Inflatable Slide.
-  No smoking or barbecues near the Inflatable Slide.
-  No climbing or jumping on the side or back walls, children may have a nasty fall or land on the fan blower causing injury. The hirer will be held responsible for the full cost incurred for any damage caused by misuse.
-  Always ensure that the Inflatable Slide is not overcrowded, and limit numbers according to the age and size of Children using it. Try to avoid large and small Children from using it at the same time.
-  Ensure children are not pushing, colliding, fighting or behaving in a manner likely to injure or cause distress to others.
-  If the Inflatable Slide is not being used for any part of the day, please switch the blower off at the mains.
-  Do not allow anyone to bounce on the end of the slide as a child could easily bounce off the inflatable and get hurt. The step is there to assist users in getting off.
-  Ensure that no-one with a history of back or neck problems is allowed on the Inflatable Slide as indeed any child who is feeling unwell.
-  Do not allow anyone to be on the Inflatable Slide during inflation or deflation as this is DANGEROUS.
-  No pets, toys or sharp instruments to be allowed on or near the Inflatable Slide.
-  Please ensure that Children are not attempting somersaults and are clothed appropriately and that nothing can fall out of their pockets.
-  The Inflatable Slide should not be used if it becomes wet. If no shower cover is fitted and in the event of rain, the unit should not be used.
-  In the event of heavy rain, it is strongly recommended that the Inflatable Slide be switched off. Any wetness, including bubbling (which is normal) can be dried with a towel.
-  In the event that the blower stops working, please ensure all users get off the inflatable immediately. The blower has a safety reset button, try pressing this, also check the fuses and make sure the blower tube or deflation tube has not come undone or something has not blown onto it and is obstructing the blower. In the event that it overheats, or loses power, switch the blower off at the mains, then switch it back on again 1 or 2 minutes later, and it should restart. If it does not, inform us straight away.
-  **PLEASE DO NOT** allow any person to jump from the top of the slide. This can result in serious injury.
-  Please make sure safety mats are in place at all times and have not moved.
