# **Terms and Conditions of Hire**

It is the responsibility of the person who is hiring the Sumo wrestling apparatus to ensure that all possible steps are taken to avoid injury or damage to the equipment or persons using the Sumo Wrestling equipment.

If you follow these simple guidelines a happy and safe time will be had by you and your guests, thank you for your time in reading this:

- Make sure that **all** the protection supplied is being worn,
- The mats provided are not wrestling mats they are Sumo Wrestling mats, to be used with all of the Sumo Wrestling equipment hired only.
- Make sure that the helmet is being worn is secure. It should be fitted onto the user's head, not too tight so as to choke but it shouldn't be loose or able to move around freely.
- Make sure the neck brace is being worn, ensuring the fastening is at the front.
- The Sumo Suit comes in a one size fits all. This must be worn at all times during wrestling.
- The Sumo Wrestling mat should have plenty of clear space around the outside.
- The wrestling event should be supervised at all times.
- If anybody refuses to wear the required safety equipment, then they can't wrestle.
- No Shoes are to be worn on the Sumo Wrestling Mats.
- No drinking, eating, glasses, jewellery, pets, silly string, or sharp instruments or similar items which could cause injury or damage are to be allowed on the Sumo equipment at any time.
- Remember these are hired for fun, don't be overly aggressive or enthusiastic, hitting others excessively hard or body slamming them is not advised as this may hurt somebody.
- The idea of the game is to force your opponent onto the floor or out of the circle, <u>NOT</u> to beat or crush them as hard as you can.
